CALENDAR FOR PRE-REGISTRATION, ADMISSION AND REGISTRATION TO MASTER'S DEGREE 2024-25

- In some cases, master's degrees may merge the first and second phase. If they do, candidates may exceptionally be admitted in advance provided that their final admission occurs in line with the official calendar.
- Depending on the allocation of places in the previous stages and in order to protect the candidates, pre-registration stages may be suspended before the end of the official period.
- Students who have been admitted in the 1st or 2nd phase but have not made the payment to reserve a place will be allowed a late registration only as long as there are vacant places, authorisation is given by the academic coordinator, and the corresponding charge is paid.
- Students who have been admitted in the 1st or 2nd phase but who have not finished their access qualification must register between 10 and 19 July if they finish their degree in the June call, or between 9 and 30 September if they finish their degree in the September call.
- Students who have been admitted but have a maximum of 9 credits and the bachelor's thesis pending after the September call can apply for registration as long as there are vacant places and they follow the corresponding procedure. This does not include the Master's Degree in Legal Practice and Legal Representation, which has its own specific regulations.
- After the corresponding deadline, those candidates from the waiting list who are allowed to register are given a specific appointment and have five calendar days to do the online registration (as from the day after they have received the email allowing them to do so).
