### 1. Who is responsible for handling your data?

The organisation responsible for handling the personal data that you provide via this form is the Universitat Rovira i Virgili, which is based at Carrer de l'Escorxador, s/n, 43003, Tarragona, and the email address [info@urv.cat](mailto:info@urv.cat).

### 2. What are the contact details of the Data Protection Officer?

### 3. What do we use your data for?

The Universitat Rovira i Virgili uses the personal data that you provide via this form to regularly send you by email the electronic newsletter to which you subscribe.

### 4. How long will we keep your personal data for?

We will keep your data for as long as the newsletter is regularly sent out and for as long as you do not expressly ask us to remove your data.

## **5. What is the legal basis that gives us the right to handle your data?**

Your express consent provides the legal basis that gives us the right to handle your data.

## **6. Who will my data be shared with?**

The recipient's data are not shared with third parties, with the exception of the processor, which is MailChimp (The Rocket Science Group LLC) as provider of the electronic newsletter service to the Universitat Rovira i Virgili. [Mailchimp's privacy policy](#) can be found on their website. We will not share your data with any other third parties unless we are legally obliged to do so.

## **7. What are your rights?**

You have the right to be informed as to whether the URV is handling your personal data or not.

You have the right to access your personal data, to rectify it and to ask for it to be removed if, among other reasons, the data are no longer required for the purpose for which they were originally collected.

In certain circumstances established in article 18 of the General Data Protection Regulation, you may request the restriction of the processing of your data. In these cases, we will only retain your data for the purposes of exercising or defending any claims.

You may oppose the handling of your data for the purposes of marketing, including the creation of user profiles. The URV will cease to handle your personal data if requested to do so by you, unless there are overriding reasons not to do so or the URV needs to exercise or defend a legal claim.

You also have the right to obtain your personal data in a commonly used electronic format and to transfer them to another controller.

## **8. How can I exercise my rights?**

You can exercise your rights by writing to the Universitat Rovira i Virgili at Carrer de l'Escorxador, s/n, 43003, Tarragona or by sending an email to the [electronic registry of the URV](#).

## **9. How can I make a claim?**

If you think that your rights have been infringed, you have the right to submit a claim to the Autoritat Catalana de Protecció de Dades (Catalan Data Protection Authority). You can also submit a claim to the Data Protection Officer at the URV.
