Valid Spanish identity card, national identity card of your country, passport or NIE [ATTESTATION REQUIREMENT](#)

Formal requirements (so that you can complete the registration process):

Spanish students: photocopy of a valid Spanish identity card.

Foreign students from a member state of the European Union: original and photocopy or an attested photocopy of their national identity document issued by their country, passport or Spanish residence card (NIE) and which must not have expired.

Foreign students from a country outside the European Union: original and photocopy or an attested photocopy of their passport or Spanish residence card (NIE) which must not have expired.

If you are a foreign candidate and you have used other identity documents to pre-register, you must be aware that you will need to present the officially required documents in order to complete the registration process and also when you request the issuance of your doctor's degree certificate.

If you need the original document, we can send you a paper copy by courier, although you should be aware that you will have to pay for any postage costs.

During the following periods, no letters of admission will be issued:

- Summer: from 1 to 31 August.
- Christmas: from 25 December 2023 to 6 January 2024.
- Easter: from 29 March to 1 April 2024.
