# **TERMS AND CONDITIONS**

We highly recommend that you understand the following because your registration for language courses implies full acceptance of these general terms and conditions.

**VISA**: if you are a national of the European Union, you are exempt from a visa.

If you are not a national of the European Union:

- For a 3-month stay (maximum), you must request a tourist visa from the French Consulate in your country.
- For longer stays, you must apply for a long-stay student visa, giving entitlement to a residence permit, from the French Consulate in your country. The International Summer University of Nice issues the necessary certificates to obtain the visa, but the University is not authorized to intervene in the visa procedure.

#### **PAYMENT METHOD**

## Registration fees must be fully paid before classes start

All payments must be made in euros (€) and must include, where applicable, additional bank charges.

Payments can be made by credit card directly to the *secretariat* or by bank transfer in euros: reference 949 / UIEN 2024 / Full name of the registered student must appear clearly in the transfer order.

Students registering for a single session (Session 1 or 2 or 3) must pay the entire amount, i.e. 480 euros (or 250 euros if you are a UniCA student).

Students registering for two consecutive sessions must pay a deposit of 480 euros (or 250 euros if you are a UniCA student).

The total amount must be transferred no later than two weeks before classes start, i.e. before June 17, 2024.

**IMPORTANT**: 1) It is imperative to send us a copy of the transfer order by e-mail (<u>uien@univ-cotedazur.fr</u>) to take your registration into account. Please note the name of the bank + name of the account holder.

2) We will confirm the reception of the requested documents and the progress of your application.

3) Accommodation costs will be paid at the same time as the courses.

### **CANCELLATION OF COURSES**

The International Summer University of Nice reserves the right to delete a session depending on the number of students inscribed.
