

Resolution of rectification of errors in the Resolution of November 29, 2021, of the rector of the Rovira i Virgili University, which awards the grants for the requalification of the Spanish university system for 2021-2023 of the Rovira i Virgili University.

FACTS

1. On November 29, 2021, the rector of the Rovira i Virgili University awarded the grants for the requalification within the Spanish university system for 2021-2023 of the Rovira i Virgili University.
2. An arithmetical error has been detected in Annex III regarding candidates who exceed the threshold of points to be included in the reserve list.

FOUNDATIONS OF LAW

1. Article 109.2 of Law 39/2015, of October 1, on the common administrative procedure of public administrations, provides that public administrations may rectify at any time ex officio or at the request of the interested parties, material, fact or arithmetical mistakes existing in their acts.

I RESOLVE

First. Approve the rectification of the arithmetic error observed in Annex III of the Resolution of November 29, 2021, of the rector of the Rovira i Virgili University, which awards the grants for the requalification of the Spanish university system for 2021-2023 of the Rovira i Virgili University, because where it states: (...)

Second. Publish this resolution on the program website.

An administrative appeal can be lodged against this resolution (which terminates the administrative proceedings) with the entity that issued it, within one month, if the resolution is definitive, or if it is not, from the day after the end of the period for the resolution of the awards procedure, in accordance with articles 123 and 124 of Law 39/2015, of 1 October.

Notwithstanding the above, an administrative appeal may be lodged with the Courts of Tarragona within two months if the resolution is definitive or within six months if it is not, in accordance with articles 9.1.c and 46.1 of Law 29/1998, of 13 July, on the administrative jurisdiction.
