6. To establish that contracts will be signed for 12 months from the beginning date, which may not be later than September 30th, 2018.
7. To establish that contracted researchers must provide, within the term of one month before finalizing the contract, a report of activities that allows the evaluation of the work carried out and the results obtained.

Any interested party may lodge an administrative appeal against this resolution at the Administrative Court in Tarragona within two months, counting from the day after the list of selected candidates is published. An appeal for reversal can also be made to the Rector of the URV prior to the administrative appeal and within

one month of the day after the publication of the list of selected candidates, in accordance with the article 124 of the Law 39/2015. Appeals must be lodged using in either Catalan or Spanish.
